Cargill Deicing Technology recently received the renewal of the Mined Land Reclamation Permit for the mine in Lansing, NY. The permit "poster" that must be posted has not been received yet, but as soon as it arrives, it will be put up in our office entrance.

As discussed in several e-mails during the second week of November, Cargill is working on the annual submittals required by the permit conditions. It is expected that these will be mailed by early December this year. In subsequent years the submittals will be mailed prior to the permit anniversary of November 2.

A review of the permit revealed several changes to the language. One is the increase in the reclamation bond to \$1,000,000 which is reasonable to Cargill. The most notable change is the addition of 13. a. (8) which better defines the conditions for the DEC Consultant Services, limits Cargill's cost, and defines the payment requirements. This clause remedies a lack that existed before.

As you know, Cargill has been discussing with the DEC Division of Mineral Resources the potential for the mine to require a new shaft for ventilation of the northern reserves. At this time, the necessary work is under way to prepare an amendment to the MLRP to allow Cargill to pursue this change. In the mean time, Cargill has purchased a property for a new shaft and is preparing to mine from the present reserves toward the new shaft site. Once land mineral rights have been acquired Cargill will begin mining them.

Based on the permit conditions, item 12 b, it is understood that this mining will be allowed without restriction, as long as Cargill owns the mineral rights of the lands being mined. No notification to the Minerals Division is required by the permit, however Cargill will submit mine plans showing the land mining as part of the regular annual report or as part of a courtesy notification once those mineral rights are acquired.

Cargill will also notify the DEC Bureau of Oil and Gas Regulation as to the extent of the new mineral reserves so that Cargill can receive notification of any proposed deep wells within the nearby area.
